

## Terms and Conditions ESCR-ESTI Joint Meeting 2023

To be eligible to register for the ESCR-ESTI Joint Meeting 2023, you must be at least 18 years old. All time specifications within the ESCR-ESTI 2023 registration process refer to CET (Central European Time). Education Congress Research GmbH/ESCR-ESTI 2023 accepts no responsibility for errors or misprints.

These Terms & Conditions apply to all events and courses organised on the occasion of the ESCR-ESTI Joint Meeting 2023.

### REGISTRATION

Registration for the ESCR-ESTI Joint Meeting 2023 is to be made electronically by completing the respective registration form provided on the ESCR website ([www.escr.org](http://www.escr.org)) or ESTI website ([www.myESTI.org](http://www.myESTI.org)). Registrations without full name, complete email, postal address and date of birth cannot be processed.

Registration fees depend on the date your payment is received at the applicable bank account and will be considered as incomplete and adjusted accordingly if the payment is not received by the relevant deadline. The relevant ESCR-ESTI 2023 registration deadlines are announced on the ESCR website ([www.escr.org](http://www.escr.org)) and ESTI website ([www.myESTI.org](http://www.myESTI.org)).

### **MEMBER REGISTRATION**

Reduced member registration is available to all active ESCR and ESTI 2023 members in good standing.

### **RESIDENT/JUNIOR REGISTRATION**

Reduced resident/junior registration will be offered to residents and juniors (young radiologists in training). Residents/juniors have to send or email a letter, written on official hospital letter paper and signed by the head of department, confirming their status as such within 5 working days after online registration. In case this confirmation is not received, the registration fee will automatically be adjusted to a regular fee. The age limit for a registration as resident/junior is set at 35 years (incl. the age of 35).

### **NURSE/TECHNOLOGIST/TECHNICIAN/PHYSICIST/PHYSICIANS REGISTRATION**

Registration categorised as nurse/technologist/technician/physicist is limited in general to nurses, technologists, technicians and physicists without any academic title. Nurses, technologists, technicians and physicists have to send or email a letter, written on official hospital letter paper and signed by the head of department, confirming their status as such within 5 working days after completed online registration. In case this confirmation is not received, the registration fee will automatically be adjusted to a regular fee.

### **STUDENT REGISTRATION**

Student registration will be offered to students without any academic title. Students have to send or email a copy of their valid student picture ID together with a copy of their passport within 5 working days after online registration. In case these documents are not received, the registration fee will automatically be adjusted to a regular fee. The age limit for a registration as student is set at 30 years (incl. the age of 30).

### **SINGLE DAY TICKET**

The single day ticket is only available once per person/registration.

### **REGISTRATION OF THIRD PERSONS**

Upon registration on behalf of third persons, the registering person warrants and guarantees to be entitled to execute such registrations according to these General Terms and Conditions in the name and on behalf of such third persons by proxy and to declare any and all approvals and consents required according to these General Terms and Conditions in the third person's name and behalf.

### **PAYMENT**

Payment of registration fee can be made by credit card (VISA or MasterCard). Payment by cheque or in any other way is not accepted. Registration fees depend on the date the payment is received at the applicable bank account and will be considered as incomplete and adjusted accordingly if the payment is not received by the relevant deadline. The relevant ESCR-ESTI 2023 registration deadlines are announced on the ESCR website ([www.escr.org](http://www.escr.org)) and ESTI website ([www.myESTI.org](http://www.myESTI.org)).

### **CANCELLATION**

In case of cancellation, neither Education Congress Research GmbH, nor ESCR or ESTI will refund any registration fee(s).

### **RIGHT OF WITHDRAWAL**

#### Consequences of the cancellation

If such participant withdraws from this contract, ECR GmbH/ESCR-ESTI 2023 will refund to such participant any payments ECR GmbH/ ESCR-ESTI 2023 has received from him without delay and at the latest within fourteen days from the date on which ECR GmbH/ ESCR-ESTI 2023 received notice of the cancellation of this contract. The refund is including eventual delivery costs (except for the additional costs arising from choosing a different type of delivery by the user than the cheapest standard delivery ECR GmbH/ ESCR-ESTI 2023 offers). For the repayment, ECR GmbH/ ESCR-ESTI 2023 uses the same payment method that such participant selected in the original transaction, unless otherwise agreed with the participant; ECR GmbH/ ESCR-ESTI 2023 will not charge such participant any fees for this repayment. After cancellation the respective service cannot be accessed.

#### **POSTPONEMENT, RELOCATION, CONVERSION, REDUCTION**

In the event that it is judged advisable or necessary to have the ESCR-ESTI 2023 Joint Meeting postponed, to have the location changed or to have the ESCR-ESTI 2023 Joint Meeting converted to an online meeting or closed early due to events beyond the control of Education Congress Research GmbH/ESCR-ESTI 2023 (e.g. cancellation of flights, strikes, natural disasters, epidemics, pandemics, travel bans, official orders, closure of the event centre, etc.) Education Congress Research GmbH/ESCR-ESTI 2023 shall not be obliged to any refunds. In such event, the obligation of Education Congress Research GmbH/ESCR-ESTI 2023 shall be restricted to take reasonable efforts to relocate the ESCR-ESTI 2023 Joint Meeting for no more than seven months from the original finish date. #### **SCOPE OF ESCR-ESTI 2023 AND COVID-19 RELATED RESTRICTIONS**

ESCR-ESTI 2023 will be held onsite in Berlin/DE.

The registration fee paid for the participation in ESCR-ESTI 2023 shall entitle the participant to participate in the onsite ESCR-ESTI 2023 Joint Meeting in Berlin/DE.

If, for any reason, holding the ESCR-ESTI 2023 onsite in Berlin/DE, becomes impossible due to reasons of force majeure, including but not limited to blackout, strikes, natural disasters, pandemics, epidemics, government regulations, internet failure, hacker attack, ECR GmbH/ESCR-ESTI 2023 shall be entitled to cancel the meeting. Cancelling the ESCR-ESTI 2023 shall entitle the participant to a refund of participation fee already paid or a pre-paid registration ticket for 2024.

If, for any reason, including but not limited to government regulations, access to the congress centre where the onsite ESCR-ESTI 2023 is supposed to be staged is limited to a certain number of persons, only the number of persons permitted shall be granted access to the congress centre. The selection shall be made after the time of registration. Upon the permitted number of persons being reached,

ECR GmbH/ESCR-ESTI 2023 shall have the right to deny access to further participants. In such case, ECR GmbH/ESCR-ESTI 2023 shall publish the number of persons permitted and the deadline until which registrations shall be entitled to access to the congress centre on its websites [www.escr.org](http://www.escr.org) and [www.myESTI.org](http://www.myESTI.org) in due time. Not being granted access to the congress centre shall not entitle the participant to any refund of participation fee already paid.

In order to avoid the spread of COVID-19, ECR GmbH/ESCR-ESTI 2023 shall be entitled to restrict access to the congress centre where the onsite ESCR-ESTI 2023 is supposed to be staged as well as to any other premises where events in the course of ESCR-ESTI 2023 shall be held to persons fully and duly vaccinated against COVID-19. The respective requirements to prove such vaccination may be subject to government regulations and will be published in due time on the ESCR and ESTI websites.

ECR GmbH/ESCR-ESTI 2023 shall be entitled to request the upload of a certificate of vaccination against COVID-19 upon registration and to restrict participation of those not having uploaded such certificate of vaccination.

### **NAME CHANGES**

Name changes will be treated like the cancellation of one registration and the new registration of another participant. New registration and payment are required.

### **BADGES AND SAFETY**

### **LOST/FORGOTTEN BADGE**

Neither Education Congress Research GmbH nor ESTI or ESCR 2023 shall be liable for any damages caused by force majeure.

### **PLACE OF JURISDICTION**
